OVERNIGHT-INN ON THE RIVER-PIGEON FORGE, TN

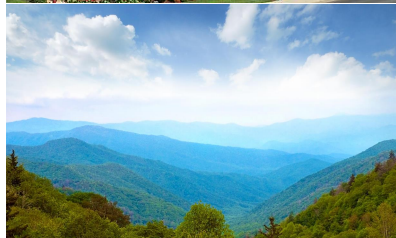
DAY FIVE, Thursday, September 12th, 2024 B, D
