SMALL WORLD TOURS AND CRUISES, INC WAIVER OF LIABILITY

WAIVER of LIABILITY.--The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is reported to be contagious. The state of medical knowledge is evolving, but the virus is believed to spread from person-to-person contact and possibly by contact with contaminated surfaces and objects or in the air. People reportedly can be infected and show no symptoms and therefore spread the disease. Evidence has shown that COVID-19 can cause serious and potentially life-threatening illness and even death to people with preexisting conditions. Small World Tours and Cruises, Inc, aka Small World Tours cannot prevent you from becoming exposed to, contracting, or spreading COVID-19 while utilizing Small World Tours's services, or entering their premises, or riding on their motorcoaches. It is not possible to prevent against the presence of the disease. Therefore, if you choose to utilize Small World Tours's services, you may be exposing yourself to and/or increasing your risk of contracting or spreading COVID-19.

ASSUMPTION OF RISK.-- I have read and understood the above warning concerning COVID-19. These services may include but are not limited to pre-packaged tours, cruises, and motorcoach transportation.

I acknowledge the contagious nature of the COVID-19 and that the CDC and many other public health authorities still recommend practicing social distancing.

I further acknowledge that Small World Tours has put in place preventative measures to reduce the spread of COVID-19.

I further acknowledge that Small World Tours cannot guarantee that I will not become infected with the Covid-19. - * I have not or will not have traveled internationally within 14 days prior to trip departure date.
- * I have not or will not have traveled to a highly impacted area within the United States of America prior to 14 days of trip departure date.
- * I do not believe I have been exposed to someone with a suspected and/or confirmed case of the COVID-19.
- * I have not been diagnosed with Covid-19 and not yet cleared as non-contagious by state or local public health authorities.
- * I acknowledge that should I begin experiencing any symptoms of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell while taking part of any services provided by Small World Tours such as, but not limited to, a pre-packaged tour, cruises, or motorcoach transportation, I will immediately remove myself from all participation on my own behalf or as requested by a member of the Small World Tours's Staff or representative. I understand and acknowledge that should I be removed on my own or by request, that I am solely responsible for any expenses that could occur including, but not limited to, added hotel stay costs, additional or return transportation costs, or medical expenses.
- * I am following all CDC recommended guidelines as much as possible and limiting my exposure to the COVID-19.

WAIVER OF LAWSUIT/LIABILITY.-- I hereby forever release and waive my right to bring suit against Small World Tours and Cruises, Inc, and its owners, officers, directors, managers, officials, trustees, agents, employees, holding companies or its affiliates or other representatives in connection with exposure, infection, and/or spread of COVID-19 related to utilizing Small World Tours's services, premises, and motorcoaches. This forever release and waiver of my rights to bring suite against Small World Tours also includes, but is not limited to, any and all vendors selected by, voluntarily or involuntarily, Small World Tours and any affiliates or partners. I understand that this waiver means I give up my right to bring any claims for personal injuries, death, disease, or property losses, or any other loss, including but not limited to claims of negligence and give up any claim I may have to seek damages, whether known or unknown, foreseen or unforeseen.
